- Registered Institutions by 'Trust' or'Company', within 18 months from the receipt of the (iv) letter of intent, as prescribed in the Right of Children to Compulsory Education Act, 2009 and the Maharashtra Right to Free and Compulsory Education of Children Rules, 2011 and the directions issued by the Government from time to time under the Act and Rules and physical facilities (such as classrooms, toilets, drinkingwater facilities, Principal room and staffroom, libraries, laboratories, etc.) will be required to comply with the above standards, terms and conditions.
- After complying with the above-mentioned facilities, it shall be the responsibility of the (v) Trust or Companyor the organization to submit an application for approval to the Area Level Authority of the concerned district within 18 months of receipt of the Letter of Intent.
- If within 18 months, the school management fails to submit an application for recognition letter, the letter of intent shall stand cancelled. The period of letter of intent shall not be extended under any circumstances.
- After the letter of intent has been issued, the location of the proposed school cannot be changed. If the management has applied for a letter of approvalfrom a location other than the one approved by the government, the letter of Intent will be cancelled.
- The State Government, may cancel a letter of intent due to breach, of any of the provisions (viii) of this Act or the rules made thereunder or failure to comply with any directions issued under the Act or standards or terms and conditions specified by the Government from time to time.
- The said institution shall be required to keep the amount specified in "Schedule C' of the Act by the said institution, Trust or Company, jointly in favor of the Management and the affiliated Education Officer(Secondary), in the form of National Savings Certificates or in the form of fixed deposits in any nationalized bank.
