Solapur institute from the academic year 2023-24. S.N.D. International School, Gat no. 570/2/C. A/P- Natepute, Tal. Malshiras, Dist. Solapur. An application was submitted for recognition of New Primary, Higher Secondary (Std. 1st to 12th. All Branches. English Medium CBSE) School on Self- Financed Basis.(Solapur)
2. In connection with your application, under the Maharashtra Self- Financed Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self Financed Schools (Establishment and Regulation) Rules, 2020, the educational and SamajbhushanNanasahebDeshmukh Education Society from 2023-24, A/P. Natepute, Tal. Malshiras Dist. Solapuroperated S. N. D. International School, Gat no. 570/2/C, A/P. Natepute, Tal. Malshiras Dist. Solapur. A New Primary to Higher Secondary (Std. 1st to 12th, All Branches, English Medium CBSE) School(Solapur), was given a letter of intent to start a new school on a self-financed basis, with terms and conditions. Now approval to start the said new school from the academic year 2023-24 is being granted subject to the following conditions.
3. Terms & Conditions:-
 - 1.The proposed school shall comply with all the standards, terms and conditions prescribed by the Parents' Right to Free and Compulsory Education Act, 2009 and the Maharashtra Children's Right to Free and Compulsory Education Rules, 2011 as stated by the Govt. under the Act
 - 2.The registered institution shall comply with all the standards, terms and conditions prescribed by the Trust or Company under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012.It is mandatory to comply with the directives issued by the government and the standards and conditions specified by the governmentfrom time to time.
 3. CBSE or CISCE or CAIE or IB etc. of the board issued Schools for Affiliation, as per the instructions issued by Govt. from time to time. From Govt. Obtaining 'No objection certificate' is mandatory.
 - 4.The school management shall inform the concerned district education authority before the commencement of the academic year as approved by the Government.
 5. Permission granted for the establishment of a new school under the provisions of this Act for the upgradation of the school, for the academic year in which it is granted

6. If the school management, within 18 months, fails to start the school, the letter of approval issued shall stand cancelled.
7. The management shall not change the approved medium of education, location of the school, in future, without the permission of the Government.
8. If the school management has established a school at a place other than the place approved by the Government, the permission of that school shall be cancelled.
9. It has been provided that the recruitment of teachers and non-teaching staff in self-financed schools should be done in accordance with the prevailing rules and regulations of the Government.
10. While filling district wise information, the school to which permission has been given shall fill the information as "Self-Financed School" as a separate category and U.D.I.S.E. will get the number. In this regard, State Project Director, Maharashtra Primary Education Council, Mumbai has been announced as the Nodal Officer.
11. School management shall put up a signboard at the entrance of the school premises saying "Self-Financed Recognised Schools".
12. The State Government may, at any time, cancel the certificate of approval on the ground of breach of any of the provisions of this Act or of the rules made thereunder, or failure to comply with any directions issued under the Act or standards or terms and conditions specified by the Government from time to time.
